328. Shri S. N. Das: Will the Minister of Education be pleased to state:

(a) whether the Viswa Bharati has begun functioning as a unitary teaching and residential University as incorporated under the Viswa Bharati Act, 1951;

(b) the important branches of learning in which research and instructions are being carried on at present;

(c) whether various authorities of the University have been constituted as envisaged in the Act;

(d) whether a full statement of the financial requirements of the university has been received by Government; and

(e) if so, the important aspects of the said requirements?

The Minister of Education and Natural Resources and Scientific Research (Maulana Azad): (a) Yes, Sir.

INVESTMENT ABROAD OF INDIAN CAPITAL

TAJ MAHAL

330. Shri Raghubir Sahai: Will the Minister of **Education** be pleased to state:

(a) for how long repairs of the **Taf** Mahal are going on;

(b) what is the total amount that has been spent so far over the repairs year-wise; (c) whether repairs are now over; and

(d) if not, how much more time will be taken to complete the work?

The Minister of Education and Natural Resources and Scientific Research (Maulana Azad): (a) The repairs have been going on since 1940-41.

(b) The total amount spent so far over the repairs is as follows:

ORDNANCE AND CLOTHING FACTORIES

331. Shri Krishna Chandra: Will the Minister of Defence be pleased to state:

(a) whether Ordnance and Clothing Factories undertake work for private bodies;

(b) if so, the nature of the work done on behalf of private bodies; and

(c) the total amount of receipts for such works executed during the years 1949-50, 1950-51 and 1951-52?

The Minister of Defence (Shri Gopalaswami): (a) Yes, to the extent capacity is available after meeting the needs of the Services.

(b) A few examples of the nature of work done for the trades/private bodies are given below:

- (i) Manufacture of Steam and Diesel Road Roller components and sub-assemblies;
- (ii) Production of Sulphuric Acid;
- (iii) Production of Acetone;
- (iv) Repairs to Binoculars, compasses, prismatic, etc.;
- (v) Forging of Crankshafts;
