#### RESIDENTIAL ACCOMMODATION TO GOVERNMENT EMPLOYEES

77. **Shri Mohanlal Saksena:** (a) Will the Minister of **Works, Housing and Supply** be pleased to state what are the Government's plans, if any, to provide accommodation to Central Government employees at Delhi on the waiting list?

(b) What is the total number of Government quarters at Delhi and have Government considered the feasibility of constructing a second storey to the existing quarters at Delhi?

**The Minister of Works, Housing and Supply (Sardar Swaran Singh):** (a) Subject to the availability of funds, it is proposed to sanction the construction of additional quarters for officers and staff, from year to year, till such time as the accommodation position eases. Accordingly, 100 flats for junior officers, 500 quarters for clerks and 500 quarters for class IV and work-charged staff were sanctioned during 1951-52 and a corresponding number has been sanctioned during 1952-53.

(b) The total number of Government quarters available in Delhi is 14,031 which includes 1,224 for officers drawing Rs. 500 and more, 8,287 for officers drawing less than Rs. 500 per month, and 4,520 for Class IV and work-charged staff.

The feasibility of constructing a second storey to the existing quarters at Delhi was considered but was not found practicable.

#### INDIANS SENTENCED TO DEATH IN MALAYA

78. **Dr. Ram Subhag Singh:** (a) Will the Prime Minister be pleased to state whether it is a fact that some Indians have been sentenced to death in Malaya during this calendar year on charges of consorting with the Communist insurgents there?

(b) If so, what is the number of Indians who have been sentenced to death?

**The Prime Minister (Shri Jawaharlal Nehru):** (a) Yes.

(b) Two.

#### KASHMIRIS SETTLED IN BHOPAL

79. **Dr. Ram Subhag Singh:** Will the Minister of Rehabilitation be pleased to state:

(a) whether some Kashmiri families of Yole Camp have been settled in Bhopal; and

(b) if so, how many families have been settled there?

**The Minister of Rehabilitation (Shri A. P. Jain):** (a) and (b). Yes. 241 families have been sent for resettlement to Bhopal.

#### TRADE WITH PAKISTAN

80. **Dr. P. S. Deshmukh:** Will the Minister of Commerce and Industry be pleased to state the nature and quantity of goods exported from India to Pakistan and vice versa during the years 1949, 1950 and 1951 together with the value of goods in each case?

**The Deputy Minister of Commerce and Industry (Shri Karmarkar):** Detailed statistics for the financial years 1949-50 and 1950-51 is given in the compilation "Indo-Pakistan Trade Statistics for the twelve months ending March 1951" which has already been published. A statement showing main features of the trade during these years and statistics for the period 1st April to 31st December 1951 is placed on the Table of the House. #### DISPOSALS DIRECTORATE

81. **Dr. P. S. Deshmukh:** Will the Minister of Works, Housing and Supply be pleased to state the strength of staff in the Disposals Directorate in each of the years 1949, 1950 and 1951 according to each category?

**The Minister of Works, Housing and Supply (Sardar Swaran Singh):** A statement showing the strength of staff (Class I, II, III and IV) in the Disposals Wing of the Directorate General of Supplies and Disposals on 1st January 1949, 31st December 1949, 31st December 1950 and 31st December 1951 is placed on the Table of the House; this shows progressive reduction in strength.

## PURCHASE OF Khadi BY GOVERNMENT

82. **Dr. P. S. Deshmukh:** (a) Will the Minister of Commerce and Industry be pleased to state what was the amount spent by the Government of India for purchasing Khadi for their requirements during the year 1950-51 and 1951-52?

(b) What was the total amount spent by the Government of India on purchase of cloth during the same period?

(c) What efforts were made to see that a larger portion of Khadi is used by the various Departments of the Government of India?

**The Deputy Minister of Commerce and Industry (Shri Karmakar):**

(a) 1950-51 ... Rs. 96,277  
1951-52 ... Rs. 67,287

(b) The value of cotton textiles purchased by Government during 1950-51 and 1951-52 is Rs. 3 crores 42 lakhs and Rs. 6 crores 97 lakhs respectively.

(c) The Government have decided to purchase as far as possible one third of their requirements of cloth in the form of handloom products including khadi.

## PERMITS

83. **Dr. P. S. Deshmukh:** (a) Will the Minister of Rehabilitation be pleased to state the number of permits issued by the High Commissioner for India in Pakistan for non-Hindus visiting India?

(b) How many of them were permits for settling down permanently?

(c) What was the number of permits issued to non-Muslims going to Pakistan from India?

(d) How many of them were permits for permanent settlement in Pakistan, if any?

**The Minister of Rehabilitation (Shri A. P. Jain):** (a) From the 19th July, 1948, the date of introduction of Permit System, upto 30th April, 1952, 1,27,283 permits covering 1,87,144 persons, were issued by the High Commissioner for India, Karachi, and the Deputy High Commissioner for India, Lahore to non-Hindus.

(b) 12,439 permits for over 29,000 persons.

(c) and (d) This information is not available with the Government of India as the permits for going to Pakistan are issued by the High Commissioner for Pakistan in India, and not by the Government of India or its officers.

## MIGRANTS

84. **Shri Jhunjhunwala:** Will the Minister of Rehabilitation be pleased to state:

(a) the total number of displaced persons who came to India from Eastern and Western Pakistan since the Partition till the 30th of April, 1952;

(b) the number of Hindus and the number of Muslims among them,

(c) the number of persons who went from India to Eastern and Western Pakistan; and

(d) the number of persons who went to Eastern Pakistan and the number of those who went to Western Pakistan?

**The Minister of Rehabilitation (Shri A. P. Jain):** (a) According to the Census of 1951, the number of displaced persons who came to India is 74-80 lakhs. The number of displaced persons who have since migrated to India is not known.

(b) Out of the total population of 74-80 lakhs displaced persons very few of them are Muslims who have migrated to the Indian Union.

(c) and (d) No definite information is available.
