The Minister of Defence (Shri Gopalaswami): (a) On 30-4-1952 the number of buildings held under requisition was 112.

(b) During the year ending 30-4-1952, 42 buildings were de-requisitioned.

(c) A sum of Rs. 6,70,159/- per annum is payable as rent for the requisitioned buildings.

Written Answers

- (d) Information is being collected and will be laid on the Table of the House.
- (e) Sub-letting of these buildings is not allowed.
- (f) So far as is known, all buildings requisitioned are occupied for authorised purposes and by authorised individuals. There is no simultaneous check of all requisitioned buildings throughout the country, but the local military authorities are required to keep a constant check to ensure this.

Information in regard to the work done during the years 1950 and 1951 will be given in (i) the Records of the Geological Survey of India, 1951, and (ii) the Records of the Geological Survey of India, 1952, copies of which will be placed in the Library of the House.

(b) It has been ascertained from the Director. Geological Survey of India, that no digging operations are being carried out at present by the Geological Survey of India as the field season, which usually lasts from November to April each year, is over.
