LOANS TO DISPLACED PERSONS OF WEST PIINJAR

- [*774. Dr. Satyawadi: Will the Minister of Rehabilitation be pleased the. to state:
- (a) the total amount of loans granted to displaced persons from the West Puniab:
- (b) the number of displaced Hari-jans granted loans and the total amount of loans; and
- (c) the maximum amount granted as loan to a Harijan?]

The Minister of Rehabilitation (Shri A. P. Jain): (a) to (c). Displaced persons from West Punjab and displaced Harijans are scattered all over the country; and no separate records are maintained for them. The labour involved in the collection of the required information will be incommensurate with the results to be achieved.

I may however inform the hon. Members that no distinction is made between a Harijan and displaced person in the grant of loans.

SERICULTURE

- *775. Shri Sarmah: (a) Will the Minister of Commerce and Industry be pleased to state whether Government have examined the method of cottage industry adopted in (i) Japan and (ii) Italy in respect of sericulture and production of silk yarn?
- (b) If so, do Government propose to lay on the Table of the House the details of the methods or plans adopted in these two countries.

The Deputy Minister of Commerce and Industry (Shri Karmarkar): (a) and (b). A body of experts were recently sent by the Central Silk Board to study the methods of cottage industry in respect of sericulture in Japan. The remarks of the Silk Board on the recommendations of the experts as to the methods and plans adopted in Japan are awaited.

No such study has been made in the case of Italy.

COTTAGE INDUSTRIES IN JAPAN

*776. Shri Sarmah: (a) Will the Minister of Commerce and Industry be pleased to state whether a critical study has been made of the (i) ways; (ii) means; and (iii) methods adopted by Japan in respect of her small and cottage industries?

- (b) If so, do Government propose to lay on the Table of the House the result or conclusion of such study?
- The Deputy Minister of Commerce and Industry (Shri Karmarkar): (a) Yes, Sir. The reports of the delegations sent in recent years to Japan to study her cottage industries have been considered by Government.
- (b) These results of and conclusions drawn from a study of these reports have not yet been finalised.

SOUTH AFRICAN SATYAGRAHA

(b) The considerations will vary according to the nature of the post will vary In the case of selection of Project Executive Officers the Operational Agreement on Community Development Programme has indicated that special regard will be paid to experience, general outlook, understanding of the needs and methods of community development, and capacity for leadership as well as ability to secure both official and non-official co-operation.
