- Shri P. T. Chacko: May I know which are the educational and cultural programmes financed till now by the Fund made available under the Agreement?
- Shri K. D. Malaviya: The educa-tional and cultural programmes which are to be financed from this Fund are the studies, research and other educa-tional activities for the citizens of America and India in these schools and educational and cultural institu-tions located in India or U.S.A.
- Shri P. T. Chacko: May I know what exactly is the aid given to a person who is sent to America from India and to a person who is coming from America to India?
- Shri K. D. Malaviya: There is some ifference between the two. The difference difference between the two. The students who are sent from here to America are provided only the transportation cost. But, the American students who come here or the Indian students who are in America and are given facilities there, get more than transportation charges, like lodging, boarding, fees etc.

**Shri P. T.** Chacko: What is the reason for this preferential treatment to persons who are sent from America to India?
