The Deputy Minister of Rehabilitation (Shri J. K. Bhonsle): (a) Yes. The Punjab and Delhi Governments have been asked to forward applicamons from about 2,400 displaced persons having verified claims who are living in a state of congestion. They will be given house-building loans upto the net interim compensation due to them. Applications have also been taken from members of house building co-operative societies and they are intended to be paid loans to the extent of the net interim compensation due to them.

(b) Loans will be advanced after the lists of eligible persons are received from State Governments and duly scrutinised to ascertain the amount of net interim compensation due to each applicant.

The Minister of Production (Shri K. C. Reddy): (a) 94 per cent. sodium chloride content.

- (b) 1st January, 1954
- (c) 37.

- (d) The sub-standard salt produced by these centres is banned for human consumption.
- (e) The information is not readily available.

RURAL HOUSING

*25. Shri Jhulan Sinha: Will the Minister of Works, Housing Supply be pleased to state the programme outlined for rural housing by in the the Rural cell established Ministry for this purpose?

The Minister of Works, Housing and Supply (Sardar Swaran Singh): The principal function of this Cell is to provide technical advice to the Community Projects Administration, in the matter of rural housing. It also tenders advice to the Development Commissioners in the States. Its programme includes the preparation of lay-outs. plans and designs for the villages, with recommendations on construction techniques and building materials, and it tries to secure the establishment of model rural centres in villages, with a view to having the models duplicated in the rest of the country-side.
