Eye set (Television Closed Circuit arrangement) is being used in certain foreign countries for demonstration and instructional purposes in educational institutions in laboratories, hospitals and certain industrial establishments.

- (b) It was only demonstrated in the Posts and Telegraphs Exhibition in Delhi and in the All India Radio Merchants' Association exhibitions in Delhi and in Bombay.
- (c) The cost of a T.V.-Eye set with a single camera chain is reported to be about Rs. 12,000.
- (d) The information is being collected and will be laid on the Table of the House in due course.

Trade between Ladakh and Central Asia

*44. Shri D. C. Sharma: Will the Minister of Commerce and Industry be pleased to state the steps that Government are taking to promote trade between Ladakh and Central Asia?

The Minister of Commerce (Shri Karmarkar): The territory adjoining Ladakh is the Tibet Region of China. The Government of India have recently entered into a trade agreement with China. Copies of the trade agreement are available in the library of the House. The agreement provides that the existing customary trade between India and the Tibet Region of the People's Republic of China should be maintained and further developed on the basis of equality and mutual benefit.
