vocational and technical training centres as well as employment in Chittaranjan Works, the Damodar Valley Project and other such projects.

Shri T. K. Chaudhuri: With reference to the answer just given by the hon. Minister that these persons are taken straight to the work-site camps, has the attention of the Government been drawn to the fact that about 300 families of displaced persons are staying in the former customs check shed of the Sealdah station in very miserable conditions? What has been done for them?

Shri J. K. Bhonsle: I could not answer that question straightaway.

Shrimati Renu Chakravartty: In view of the fact that each month the number of refugees is increasing and in view of the fact that in another 1½ months the monsoons will break out, are any arrangements being made to put up shelter and receive those who will be coming over in the border stations?

Shri J. K. Bhonsle: It is very difficult to anticipate these measures, but anyway Government wil do everything possible to see that those who come over are well looked after.

FOREIGN EXPERTS IN D.V.C.

*2005. Shri R. P. Garg: Will the Minister of Irrigation and Power be pleased to lay a statement on the Table of the House showing:

- (a) the number of foreign experts working at present in the Damodar Valley Corporation;
 - (b) their number, country-wise; and
- (c) the terms and conditions of their service?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) to (c). A statement is laid on the Table of the House. [See Appendix IX, annexure No. 38].

Shri R. P. Garg: Have the Government of India received any complaints about these foreign experts from our own engineers and specialists work-

ing with them? If so, what steps do Government propose to take to remedy their complaints?

Shri Hathi: No complaint has been received.

Shri K. K. Basu: May we know whether we have Indian under-studies in respect of all the foreigners employed here, and which is the latest time by which they are expected to leave this D.V.C.?

Shri Hathi: If the hon, Member refers to the statement, there is only one engineer, the Chief Engineer, who is in the employment of the D.V.C. The others are experts under the various aid programmes. We have, however, understudies placed under these exports.

Shri R. P. Garg: May I know, Sir. Mr. Speaker: Next question.
