(b) if so, whether the inclusion or exclusion of the Scheduled Castes in the list will affect the allocation of seats in the Legislatures for the next General Elections?

CUSTOMS EMPLOYEES

*794. Shri Gidwani: Will the Minister of Finance be pleased to state:

(a) whether it is a fact that the Ministry of Home Affairs, have issued certain orders in connection with the confirmation and seniority of displaced Government employees to various Ministries; and

(b) if so, whether these orders have been implemented by the Customs authorities at Bombay, Calcutta and Madras?

The Minister of Revenue and Defence Expenditure (Shri A. C. Guha): (a) The Ministry of Home Affairs have issued no special orders governing the confirmation of displaced Government servants only, but they have issued specific instructions about the manner of the fixation of seniority of displaced Government servants.

(b) Yes, Sir, except in four cases out of 91 due to some technical difficulties. These are under consideration in consultation with the Ministry of Home Affairs.

Shri Gidwani: Will the Government expedite the disposal of those four cases also?

Shri A. C. Guha: Only four cases are remaining out of which in the case of three there was some break of service; either the persons had resigned or absented themselves before joining here. So there was this technical difficulty. In the other case the person is educationally not qualified.

Mr. Speaker: He wants to know whether Government will expedite their disposal.

Shri A. C. Guha: We are trying $t_{i'}$ expedite as much as possible.
