have rehabilitated from the year 1950 to date is as under:

Of the numbers shown against (i) and (ii) above, it is not possible to state how many belong to the Scheduled Castes. Out of the total number shown against (iii) i.e. land colonies however, it can be stated that 104 belong to Scheduled Castes. The land in question was allotted on 20 years' lease on a nominal annual rent of Rs. 5 per ace.
