Highri Janian Sinha: In view of the **Maanimous** opinion held in the country by official as well as non-official bodies on this point, may I know whether Government consider it desirable to issue a statement setting forth the detailed grounds for the difference of opinion with an expert body like the Indian Sugarcane Committee?

Dr. P. S. Deshmukh: It is wrong to suggest that there is so much unanimity as my hon. friend thinks there is. For instance. I could tell him that most of the State Governments were content to have Rs. 1-7-0 as the rate of sugarcane.

Pandit D. N. Tiwary: May I know whether Government have ever attempted to link the price of sugar with the cost of sugarcane?

The Minister of Food and Agriculture (Shri A. P. Jain): An experimental scheme is being conducted by the Indian Central Sugarcane Committee now to find out the cost of production.

Shri Heda: In view of the fact that the suggestions regarding sugarcane price made by Government or the formula suggested by Government are to be accepted on a voluntary basis. and since in many cases many of the milis do not follow it, may I know whether Government think that whatever suggestions or formula are laid down by them should be followed compulsorily?

Shri A. P. Jain: So far as the question of acceptance is concerned, all the mills have accepted even on the voluntary basis. As I stated the other day in the House, we are going to appoint a committee to consider the whole question of linking the price of sugarcane with the sale price of sugar, including the share in the profits.

चिंगलपेट में कून्ट रोग गर्ववणा संस्था

•८६७. श्री कृष्णाचार्य जोती : क्या स्वास्थ्य मंत्री यह बताने की कृपा करोंगी कि कुष्ट शेग गवेषणा संस्था, चिंगलपेट मद्वास में किस प्रकार का गवेषणा कार्य किया जाता हैं ?

स्वास्थ्य मंत्री (रावखुवारी अमृत कार): कुष्ट रोग के लित्रामेटस' मरीजों को दिये गये बीo सीo जीo के टीके के प्रभाव पर आँर बच्चों में फॉले हुए कुष्ट रोग की व्यापकता सम्बन्धित स्राजें जो लेडी विलिगडन लिप्रोसी सॅनंटोरियम, तिरुमणि, जिला चिंगलपेट और बच्चों के लिये सिलवर जुबिली चिलडून्स क्लीनिक, सँख्यदपेट में हो रही थी, वही अनुसन्धान अभी केन्द्रीय कुष्ट रोग शिच्चण व अनुसन्धान संस्था में, जिसकी संस्थापना ४ जनवरी, १६४४ को हुई हैं, जारी हैं । संस्था के डायरक्टर की नियुक्ति के बाद अनुसन्धान सम्बन्धित कार्य ह्वेत्र को बढ़ाने के प्रस्न पर विचार किया जायेगा ।

Shri Krishnacharya Joshi: May I know whether Government have considered the various recommendations mode by the Leprosy Conference recently held at Jamshedpur?

Rajkumari Amrit Kaur: Yes. Naturally, all suggestions made by the important conference held recently are always considered. In this particular aspect of the Central Research Institute, a committee was set up in 1948, and it made its recommendations, a majority of which has been accepted.

Shri Krishnacharya Joshi: Regarding research work, a suggestion w#s made by the president of the Conference, Shri G. V. Mavalankar in his address that:

"The new Central leprosy teaching and research institute at Madras would no doubt make its own contribution in addition to research by qualified men in laboratories and in the field, but the asylums might also have a research section where qualified research workers could carry on research work."

Will this proposal be accepted by Government?

Rafkumari Amrit Kaur: Certainly, it will be given the consideration it merits.

Dr. Suresh Chandra: Have Government any statistics with regard to the exact number of lepers in this country?

Rajkumari Amrit Kaur: It is very difficult to say, but we reckon that there are at least 2 million lepers in India.

Dr. Rama Eao: I understand the hon. Minister as saying in Hindi which I did not understand well—that they are trying BCG vaccination as a method of prevention in Chingleput. May I know if any conclusions have been drawn on the experiment?

Rajkumari Amrit Ksur: The experiment with BCG has only just begun and it is therefore too early to give results.

•868. Pandit D. N. Tiwary: Will the Minister of Railways be pleased to state:

(a) the number of waiting halls and sheds constructed on the North-Eastern Railway during the year 1954; and

(b) whether it is a fact that at the Dighwara railway station an upper class waiting room has been constructed instead of a third class passengers' shed as originally planned? The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan): (a) 9 waiting halls and sheds for III Class and 7 waiting rooms for Upper Class passengers.

(b) It is a fact that an upper class waiting room has been constructed at Dighwara as none was existing to meet the requirements of upper class traffic dealt with at this station. However the work of extending the existing third class waiting accommodation will also be taken up shortly.

श्री शाइनवाव स्वां : वहां दिघवारा में एक वेटिंग इांल हें जो बुर्जिंग विंडो का वेटिंग हाल हें और उसके लिये यह सुना गया हें कि २९४ मुरव्वा फुट जगह वहां के थर्ड क्लास के मुसाफिरों के लिये काफी हें लेकिन उसके बरअक्स २४२ मुरव्वा फुट जगह वहां पर धर्ड क्लास के पॅसेंजर्स के लिए मॉज्द हें, अब हमारं आनरंबुल मेम्बर वगॅरह भी वहां पर जाते रहते हैं तो उनके वास्ते हमने अपर क्लास का वेटिंग हांल भी बना दिया हैं।
