# GOODS TRAFFIC

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shannawaz Khan): (a) There is no indication of any large increase in the transport of goods by road in Saurashtra and in Assam; but there has, however, been a small increase in 1953-54 and 1954-55, in the number of permits issued for public carriers in these States.

## VENDING CONTRACTS

\*2528. Th. Jugal Kishore Sinha: Will the Minister of Railways be pleased to state:

- (a) the punishment prescribed the sub-letting of vending contracts on Railways;
- (b) whether there is any periodical check against such sub-letting; and
- (c) the number of cases reported in the North Eastern Railway during the last two years and the action taken thereon?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawae Khan): (a) Railhave been instructed to be particularly strict in dealing with sub-letting of contracts.

- (c) Eleven cases in the financial years 1952-53 and 1953-54. In seven cases which were proved the contracts were terminated. In the remaining four cases the were not substantiated.
