plan for expansion submitted by the Tatas which was under the consideration of the Government?

Shri Kanungo: The first expansion scheme has been approved and it is under way. This question relates to the second expansion scheme.

Shri T. B. Vittal Rao: What will be the additional output under the first expansion scheme?

The Minister of Commerce and Industry and Iron and Steel (Shri T. T. Krishnamachari): From 7,50,000 to 9,30,000 tons of finished steel.

## **Chemical Fertilisers**

\*785. Th. Jugal Kishore Sinha: Will the Minister of Commerce and Industry be pleased to state:

- (a) the exact output vis-a-vis the installed capacity of chemical fertilisers during 1954; and
- (b) the reasons for the difference between the output and the installed capacity?

The Minister of Industries (Shri Kanungo): (a) A statement it is laid on the Table of the House. [See Appendix V, annexure No. 34]

(b) M/s. Sindri Fertilisers and Chemicals Ltd., could not attain full rated capacity for Ammonium Sulphate during 1954. M/s. Fertilisers & Chemicals (Travancore) Ltd. who produce Ammonium Sulphate and Super-phosphate were closed down for three months on account of major repairs and power shortage. In the case of super-phosphate, production was below the rated capacity as there was not enough demand for this fertiliser.

भी एम॰ एल॰ क्रिवेदी: किस किस्म का प्रचार किया जा रहा है?

भी कानूनगो : यह प्रश्न ग्रगर फूड हैंड एग्रीकलचर मिनिस्टरी से पूछा जाये तो जवाब मिल सकता है ।

## Steel Plant in PEPSU

\*786. Shri Subodh Hasda: Will the Minister of Planning be pleased to state:

- (a) whether it is a fact that the PEPSU Government have sent a proposal for the setting up of a steel plant in that State; and
- (b) if so, the decision taken in the matter?

The Deputy Minister of Planning (Shri S. N. Mishra): (a) No definite proposal has been received.

(b) Does not arise.

## Small Scale Industries

788. Shri Viswanatha Reddy: Will the Minister of Commerce and Industry be pleased to state:

- (a) whether any data regarding the possibilities of starting small scale industries at various places have been collected by Government; and
- (b) the nature of the proposals finalised so far ?

The Minister of Industries (Shri Kanungo): (a) and (b). Data are being collected.

Shri Viswanatha Reddy: May I know whether the technical consultants for small-scale industries of the Ford Foundation, who are giving advice to the Government, have been consulted in this respect?

Shri Kanungo: Some of them have gone away and the economic advisers we have got are being consulted.

Shri Viswanatha Reddy: Have they submitted any report?

Shri Kanungo: Not yet.
