- (b) The annual recruitment rate for the I.A.S. I.P.S. cadres of the various States is prescribed on an actuarial basis. Actual recruitment in any particular year may, however, vary according to the actual gaps in the State Cadres.
- (c) Direct recruits to the Indian: Administrative Service are allotted to the various States having regard to the preferences expressed by them and their-relative positions in the merit list, as also to the policy of the Government to allot a definite proportion of 'outsiders' to each State Cadre with a view to maintain the Allotalindia charcacter of the Service. Allocation of direct recruits to the Indian Police Service Cadres of the various States is, as far as possible, made from amongst the candidates qualifying for appointment from the States concerned or an adjacent part 'C' State.
