

Family Survey of Indian Villages

*2379. **Shri Sanganna:** Will the Minister of Planning be pleased to state whether the economic aspects as revealed by the family survey of Indian villages conducted by the Government of India are being taken into consideration while preparing the Second Plan frame of the country?

The Deputy Minister of Planning (Shri S. N. Mishra): Presumably the hon'ble member has in his mind the family survey conducted either under the Agricultural Labour Enquiry or under the National Sample Survey. We are utilising all the data furnished by these surveys for the preparation of the Second Five Year Plan.

Technical aid from Russia

The Minister of Commerce and Industry and Iron and Steel (Shri T. T. Krishnamachari) : (a) and (b). The Ministry of Commerce and Industry have not sent a team of officials in the recent past to U.S.S.R.

Western India Match Company

*2383. **Shri H. N. Mukerjee :** Will the Minister of Planning be pleased to state:

(a) whether a memorandum has been received from the workers of the Swedish-owned Western India Match Company, Calcutta;

(b) whether Government's attention has been drawn to the danger implicit in the Company's production schemes to the small and cottage production of matches; and

(c) if so, the steps Government propose to take in the matter?

The Deputy Minister of Planning (Shri S. N. Mishra): (a) No such memorandum is traceable.

(b) Government are not aware of the production schemes of the Company or of any danger therefrom to the Small and Cottage production of matches. No expansion of WIMCO's capacity is being permitted.
