## Inland Steam Vessels

\*1045. Shri Shree Narayan Das : Will the Minister of Transport be pleased to state:

(a) whether the proposal with regard to amending the Inland Steam Vessels Act, 1917 with a view to confer on the Central and State Governments the power to regulate the recruitment of crews on inland steam vessels as recommended by the Ganga-Brahmaputra Water Transport Board has been considered and decision taken thereon; and

(b) if so, the decision of Government

The Deputy Minister of Railways and Transport (Shri Alagesan): (a) and (b). Government have agreed in principle with the recommendation of the Ganga-Brahmaputra Water Transport Board and proposals for amendment of the Inland Steam Vessels Act, 1917 have been forwarded to the State Governments of Uttar Pradesh, West Bengal, Bihar and Assam for comments.

Shri Shree Narayan Das: May I know when the amending measure is likely to come and whether it will be considered by the State Government or by the Central Government?

Shri Alagesan : The Centre will have to enact the legislation.

Shri Shree Narayan Das : May I know whether the opinions of the State Governments have been received so far?
