Railway Accident

- (a) whether it is a fact that what would have resulted in a menor train disaster was averted at Bhairongarh station near Ratlam (Western Railway) on the 22nd November, 1955 when the 33 Down Bombay Express was seen coming on the same track where a huge crane was in operation;
- (b) if so, the circumstances in which the disaster was averted; and
- (c) whether it is a fact that one Shri Amba Lal, Carriage Inspector's body was crushed under the wheel of the engine in his attempt to stop the incoming train?

The Parliamentary Secretary to the Minister of Railways and Transport (Shri Shahnawaz Khan): (2) and (b). At about 12:32 hours on 22-11-1955 while No. 33 Down Dehra Dun Express was being received on line No. 2 of the Bhairongarh Starion on the Ratlam-Godhra Section of the Western Railway, it collided with the counterweight of the crane which was at that time fouling the line.

(c) It is a fact that Shri Amba Lal, Carriage and Wagon Inspector, was killed but the exact circumstances in which this happened will be known when the final report of the Government Inspector of Railways, who held his enquiry into the accident, is received.
