#### Small Scale Industries in Punjab

\*167. **Shri D. C. Sharma :** Will the Minister of Commerce and Industry be pleased to refer to the reply given to Starred Question No. 317 on the 2nd of August, 1955 and state:

(a) whether Government have received any report from the Government of Punjab with regard to the establishment and development of small scale industries in that State; and

(b) if so, whether it has been considered ?

**The Minister of Commerce and Industry and Iron and Steel (Shri T. T. Krishnamachari) :** (a) and (b). A statement is placed on the Table of the House. [See Appendix I, annexure No. 41].

**Shri D. C. Sharma :** In the statement, 14 main items are listed. Out of these 14 items, there are 6 items above which it is stated that the State Government has cropped the schemes. There are two other items about which it is stated that the State Government has withdrawn the schemes. About two items it is stated that they are under consideration. May I know if the State Government has advanced any reasons for the dropping of the schemes and also for the withdrawal of the schemes and also if the Central Government has found those reasons to be cogent and convincing ?

**Shri T. T. Krishnamachari :** The facts are not disputed. The Central Government is not in the position of an appellate authority in a matter like this. If the hon. Member wants more information, he has got to address it to the proper quarter, that is, the State Government.

**Shri D. C. Sharma :** May I know how long it will take the Central Government to take action on schemes 10 and 11, that is to say, creation of guarantee fund under the scheme of the State Government to guarantee loans advanced by co-operative society banks to industrial co-operative societies and staff for the Directorate of Industries ?

**Shri T. T. Krishnamachari :** So far as item 11 is concerned, it will be settled very soon. So far as item 10 is concerned, the matter will take a certain amount of time, because it is a matter of elaborate procedure and a question of creation of an agency which cannot be done within a short period of time.

**Shri D. C. Sharma :** May I know the total amount of loan that was advanced to the State during the last year for these small-scale industries and the amount that has been given to the Government during the current year and how they compare ?

**Shri T. T. Krishnamachari :** The amount sanctioned during 1955-56 to the Punjab Government in respect of small-scale industries has been Rs. 30 lakhs. I am not able to say what amount has been disbursed.

**श्री विभूति मिश्र :** क्या सरकार को पता है कि चम्पारन, सारन और मुजफ्फरपुर में एक नोनिया जाति होती है जिस की जीविका शोरा के रोजगार से चलती है ? तो क्या सरकार इस रोजगार को डेबेलप करेगी ताकि नोनिया लोगों की जीविका चल सके ?

**वाणिज्य मंत्री (श्री करमरकर) :** माननीय सदस्य ने चम्पारन के बारे में शायद कुछ कहा है। जी हां, राजस्थान गवर्नमेंट और यू० पी० गवर्नमेंट के कुछ प्रोपोजल्स हैं जिन पर सोच विचार हो रहा है।
