PHIZO'S ACTIVITIES IN N.E.F.A.

*1067. Shri Vallatharas: Will the Prime Minister be pleased to state:

- (a) whether Government are aware of the fact that the rebel Naga Leader, Phizo, is collecting arms and ammunitions from outside to free Naga Hills and to combat with the Indian Military which is since engaged in the area to arrest the rebel gang and to arrest Phizo; and
- (b) the present policy of Government towards the rebel gangs and the maintenance of law and order in the Naga area?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): (a) Government are aware that Phizo has made efforts to collect arms and ammunition and has organised a violent movement in the Naga

- Hills. There is, however, no evidence so far of his having been able to secure any foreign arms and ammunition.
- (b) Government are taking necessary action for the suppression of this violent movement and for the maintenance of law and order.

- *1072. Shri T. B. Vittal Rao: Will the Minister of Production be pleased to state:
- (a) whether the report of the Experts Committee appointed to go into the question of economic working of the Giridih Collieries, Bihar has since been examined by Government;
- (b) whether any decisions have been arrived at; and
- (c) whether Government propose to lay a copy of the report on the Table of the House?
