MANIPUR STATE TRANSPORT DEPART-MENT

*1277. Shri Rishang Keishing: Will the Minister of Home Affairs be pleased to refer to the reply given to Unstarred Question No. 654 on the 19th December, 1955 and state the progress made by the Delhi Special Police in the investigation into the defalcation case in the Manipur State Transport Department?

The Minister in the Ministry of Home Affairs (Shri Datar): The matter is still under investigation.

Shri Rishang Keishing: What is the exact amount of money and number of officers involved in this case?

Shri Datar: The amount suspected to have been misappropriated is in the level of Rs. 50,000.

Shri Rishang Keishing: The number of officers?

Mr. Speaker: The number of officers involved.

Shri Datar: I am not aware of the exact number of officers.

Shri Rishang Keishing: Why have the Government singled out this case for investigation by the Delhi Special Police?

Shri Datar: It was considered that the amount was fairly large and as it required expert investigation, thereforce, it was entrusted to the Special Police Establishment.
