Shri Jawaharlal Nehru: This is an exhibition of modern book publications. The hon. Members will realise how the modern books are produced in the various Indian languages. It is more an exhibition of modern publications and the type of books that are published than the contents of books. People do not read the contents in an exhibition. They want to see how in the modern Indian languages books are being produced.

DISTRICT SOCIAL EDUCATION ORGANISERS

*2243. Shri Ram Krishan: Will the Minister of Education be pleased to state the main features of the Scheme for appointment of District Social Education Organisers?

The Deputy Minister of Education (Dr. K. L. Shrimali): A statement is laid on the Table of the House. [See Appendix XIII, Annexure No. 43.]

श्री राम कृष्ण: ग्रबतक इनकी ट्रेनिंग के लिये क्या क्या इन्तिजाम किया गया है?

बा० के० एल० श्रीमाली: उनके लिये ट्रेनिंग का कोई खास ग्रलग प्रबन्ध नहीं किया गया है। जैसा कि स्टेटमेंट में बतलाया गया है जो लोग भोग्य होंगे वे ही इन पदों पर नियुक्त किये जायेंगे।

Dr. Rama Rao: May I know the special functions of the Social Education Organisers and how they differ from the ordinary Education Inspectors? Do they work in the ordinary educational institutions or do they work in special social education institutions?

Dr. K. L. Shrimali: I may correct what I said a minute before. Some arrangement is being made by the Community Projects Administration, with regard to the training of Social Education Organisers. With regard to the question that has been raised just now, I may say that the main function of these organisers was to bring about a kind of co-ordination between the work that is being done by the Community Projects Administration in the field of social education

and the work that is being done by the State departments of education. At present there is no agency to coordinate the work between these two departments. We are expecting that by the end of the Second Plan Period the whole country will be covered by the Community Projects and the National Extension Service. therefore, essential that somebody like the Social Education Organiser should be appointed in the district, so that he might bring about co-ordination between the work of the community projects administration, social education programme and the work that is being done by the State departments of education that will be having social education organisations.

सेठ गोविंद दास: क्या माननीय मंत्री जी यह बात जानते हैं कि भिन्न भिन्न राज्यों में समाज शिक्षा का पाठ्यक्रम और पद्धति भ्रलग भ्रलग तरह की है भौर क्या इस बात प्रयत्न किया जा रहा है कि यह पाठ्यक्रम और पद्धति सारे देश में करीब करीब एक सी बना दी जाय ?

डा० के० एल० श्रीमाली: न तो एक सी बनाई जा सकती है और न मेरी दृष्टि से यह वांछनीय है क्योंकि हर एक स्टेट की समस्यायें भ्रलग भ्रलग होती हैं भीर उन को इस बात का पूरा मौका होना चाहिये कि वह भ्रपना पाठ्यक्रम भ्रीर पाठ्य विधि बनायें।

Shri M. D. Joshi: May I know whether these district social organisers will work under the district social education committees or under the community projects administration or under both?

Dr. K. L. Shrimali: No, Sir. They will be appointed by the State Governments.

Shri D. C. Sharma: May I know in what way these district social organisers will be recruited and whether they will be directly under the State Governments or both under the State and the Central Governments?

Dr. K. L. Shrimali: No, Sir. They will be under the State Governments. The Central Government will only give grants to the State Governments for the appointment of these officers.

RECRUITMENT OF SUB-INSPECTORS OF POLICE

- *2244. Shri M. L. Agrawal: Will the Minister of Home Affairs be pleased to state:
- (a) whether it is a fact that by an advertisement in the *Statesman* of 5th May, 1955 Government invited applications for the recruitment of Sub-Inspectors of Police; and
- (b) if so, how far the recruitment has progressed?

The Minister in the Ministry of Home Affairs (Shri Datar): (a) Yes.

(b) Twenty candidates were selected who are now undergoing training.

Shri M. L. Agrawal: May I know how many candidates have been selected and how many applied?

Shri Datar: The number of persons who applied is very large—more than 10,000—and 20 candidates were selected.

Pandit D. N. Tiwary: May I know what is the method of selection?

Shri Datar: The selection is made by two committees; one is a preliminary local selection board which sits at different centres, about 17 in all, and the final selection is made by the central selection board here.

Pandit D. N. Tiwary: Who are the members of the local selection board?

Shri Datar: They are officers of the Intelligence Department.

Shri M. L. Agrawal: What are the qualifications prescribed for the candidates?

Shri Datar: So far as the qualifications are concerned, there are two categories of Sub-Inspectors: ordinary and technical. For ordinary Sub-Inspectors B.A. or B.Sc. is essential and for technical Sub-Inspectors B.Sc.

with physics and mathematics is essential.

Shri M. L. Agrawal: May I know what steps are going to be taken to recruit the required number of candidates?

Shri Datar: I could not follow the question, Sir.

Mr. Speaker: Nor have I.

Shri M. L. Agrawal: I want to know, what steps are going to be taken to recruit more Sub-Inspectors who are required.

Shri Datar: *Our requirements are about 20 every two years. Therefore, we cannot accommodate others.

श्री भक्त बर्जन : क्या यह सत्य है कि यह सिमिति लगभग पिछले ढाई वर्ष से कार्य कर रही है ? मैं जानना चाहता हूं कि क्या खास ग्रहचनें हैं जिनकी वजह से निर्णय करने में देरी हो रही है ।

डा० के० एक० श्रीमासी: मुझे इस बात का बड़ा प्रफसोस है कि इस कमेटी की रिपोर्ट जल्दी नहीं तैयार हो सकी। लेकिन जहां तक मिनिस्ट्री का सम्बन्ध है, उन्होंने इस बात की पूरी कोशिश की कि जल्दी से जल्दी यह रिपोर्ट तैयार हो जाय। दिक्कत यह है कि कुछ पालिया-मेंट के मेम्बर इसके सदस्य है ग्रीर चेयरमैन भी पालियामेंट के मेम्बर हैं, वह भी काम में
