EXPENDITURE ON FIVE YEAR PLAN

- *815. Shri Satyendra Narayan Sinha: Will the Minister of Finance be pleased to state:
- (a) whether it is a fact that State Governments have represented to the Government of India that it was difficult for them to supply exact figures of expenditure on Five Year Plan schemes to the Planning Commission; and

The Deputy Minister of Finance (Shri B. R. Bhagat): (a) A representation to that effect was made by a State Government some time ago.

(b) Plan expenditure is inextricably mixed up with the ordinary expenditure in most cases and its complete segregation in the accounts is not practicable without major structural changes, both in the accounts and in the form of bills and vouchers.

Departmental authorities are, however, expected to maintain pro forma accounts of Plan expenditure from their own records and such other details as may be available in the regular accounts. The question of eliminating delays and difficulties in the maintenance of such accounts is kept under constant review.
