ASSAM OIL FIELDS

- *2369. Shri Bhagwat Jha Azad: Will the Minister of Natural Resources and Scientific Research be pleased to refer to the reply given to a supplementary raised on Starred Question No. 1722 on the 25th April, 1956 and state:
- (a) whether assessment has been made of the quantity of oil in the new finds of Assam oil fields; and
 - (b) if so, the results thereof?

The Minister of Natural Resources (Shri K. D. Malaviya): (a) and (b). The Assam Oil Company have obtained an estimate over part of the area through a firm of consultants as amounting to about 18 million tons.

MILITARY TRAINING

*2373. Shri H. G. Vaishnav: Will the Minister of Defence be pleased to refer to the reply given to Starred Question No. 2035 on the 8th May, 1956 and state the approximate number of civilians who will be given Military training till the end of 1956?

The Deputy Minister of Defence (Sardar Majithia): The scheme is being run as an experimental measure at three centres and each centre is designed to train 120 volunteers at a time. The training is given until a candidate becomes proficient. In absence of a prescribed minimum duration of the training, the total number likely to be trained by the end of 1956 cannot be forecast.

*2377. Shri Deogam: Will the Minister of Education be pleased to state whether any steps have been taken to collect and publish tribal folk-songs in various tribal languages as an aid to Social Education among the Tribals?

The Deputy Minister of Education (Dr. M. M. Das): The matter is under consideration.

I.A.S. EMERGENCY RECRUITMENT

- *2386. Shri D. C. Sharma: Will the Minister of Home Affairs be pleased to state:
- (a) the reasons which influenced Government in prescribing a monthly income of Rs. 300 as a condition of eligibility for recruitment to the I, A. S.;
- (b) whether in the case of a non-Government servant, pay and all allowances will constitute the income required under the qualifications;
- (c) if so, the reasons why in the case of a Government servant, pay and dearness allowance have only been taken into account and not the total emoluments; and
- (d) whether Government propose to consider the question of including the total emoluments of Government servants for the purpose of computing the income?

The Minister of Home Affairs (Pandit G. B. Pant): (a) The Special Recruitment to the I.A.S. is intended for selection of persons with experience. One of the criteria on which experience can be evaluated is the income derived therefrom. From this point of view, an income level of Rs. 300 p.m. is not excessive.

- (b) No; only Dearness Allowance is included, and that is both for Government servants and for non-Government servants.
