INDIAN CIVIL AVIATION STAFF IN KABUL

**\*971. Shri B. Y. Reddy :** Will the Minister of Communications be pleased to state :

(a) whether it is a fact that Indian Radio Team of Civil Aviation Department of Kabul are being paid in Afghan Currency; and

(b) if so, whether Government are aware that they are undergoing financial difficulties due to very low · official rate of exchange compared to the Indian market?

The Minister in the Ministry of Communications (Shri Raj Bahadur): (a) Yes, in the same way as the Indiabased staff of the Indian Embassy, Kabul. (b) Government have received representations and these are under consideration.

Admission to Medical Colleges

**\*972.** Shri Sinhasan Singh: Will the Minister of Health be pleased to state whether Government had issued any circular to the effect that in selection of candidates to medical colleges in different States the question of domicile should be avoided and that the best students irrespective of their domicile should be selected?

The Minister of Health (Rajkumari Amrit Kaur): The Central Council of Health at their 3rd meeting held at Trivandrum in 1955 had passed a resolution recommending that the State Governments should explore the possibility of liberalising their policy in the matter of admission to medical colleges and charging of capitation fees and remove all restrictions on admission of students who have obtained the pre-medical qualification of the require standard irrespective of their domicile. A copy of this resolution was forwarded to the State Governments for information and necessary action.
