The Deputy Minister of Production (Shri Satish Chandra): (a) Since the All India Khadi & Village Industries Board function as present in an advisory capacity, its staff is recruited according to the normal rules applicable to other Government cmpl oyats, except in such cases where exemption is granted due to special circums success.

- (b) Administrative posts are filled up by the Ministry on the recommendations of the Board, with the approval of the Union Public Service Commission where necessary.

- (d) The Board was satisfied that the qualifications and experience of the incument is stiffed his appointment as Director of Development on a temporary basis. Union Public Service Commission have subsequently agreed to this appointment upto the end of February 1957.
