- 6. Dispensers and Compounders.

- 8. Skilled Artisans,
- Other categories of clerical, nonclerical and artisan personnel.

Damage to Crops in West Bengal

*2133. Shri K. K. Basu:

Will the Minister of Food and Agriculture be pleased to state:

(a) wnether there has been large scale damage to crops in the Sundar bans areas of West Bengal during the last three weeks due to inflow of saline water;

- (b) if so, the reasons therefor;
- (c) if so, the total damage done to crops and men and the number of human lives lost and properties; and
- (d) what measures have been taken for relief and protection from further damage?

The Minister of Food and Agriculture (Shri A. P. Jain): (a) Crops in 17,300 acres of land are reported to have been so damaged.

- (b) Breaches in the earthen embankments caused by abnormal tidal bore and consequent inundation of fields by saline water.
- (c) No precise assessment of damage caused to crops and properties is available. No soss of human sife has so far been reported.
- (d) Loans and grants of over Rs. 35 lakhs has been sanctioned. Clothes, blankets and 13,000 maunds of paddy have also been distributed as gratuitous relief. 412 out of 445 breaches have been closed and weak points in embankments are being strengthened. Water in about 3/4th of the inundated areas has been drained out.
