Dr. P. S. Deshmukh: That 15,000 tons of rice was sent as a loan. We have also promised to supply 50,000 maunds of paddy for seed purposes.

Written Answers

Shri Bhagwat Jha Azad: Did they give any indication as to by what time they would return it?

Dr. P. S. Deshmukh: This is expected to be returned as soon as their new crop comes. We expect that it will be returned before November.

Shri Gidwani: Are Government aware that Pakistan has been exporting rice to other countries?

Dr. P. S. Deshmukh: I am not aware.

Shrimati Tarkeshwarl Sinha: Government have made gifts and loans of the order of 50,000 and 60,000 maunds of rice. In view of the fact the rice shortage is nearly one million tons in this country, may I know how far it is in conformity with the policy of Government to reduce the price of rice, that they should make gifts and loans of this order?

Dr. P. S. Deshmukh: It is not 50,000 or 60,000 tons.

Shrimati Tarkeshwari Sinha: Maunds.

Dr. P. S. Deshmukh: 50,000 maunds of paddy have been promised for seed purposes, and 15,000 tons of rice were given as loan. As everybody knows, Pakistan was in a very bad condition, and they wanted this badly. By way of help to us, they have given us a loan of 15,000 tons of wheat. The two transactions are not however to be cancelled against each other.

- (d) This is a stop gap arrangement to meet shortages in staff caused by heavy absenteeism and to avoid delay in opening small exchanges caused due to want of trained Telephone Operators and due to high operating cost.
- (e) Rs. 35-1-50 plus special pay of Rs. 5/- p. m.
