The Minister of Defence Organisation (Shri Tyagi): Two defendants have delivered their defence and counterclaim and the third defendant has submitted defence statement only. Replies thereto are under preparation

Budget Leakage Case

Migration from Pakistan-held Kashmir Territory

45-A Shri Krishnacharya Joshi: Will the Minister of Home Affairs be pleased to state:

(a) the total number of persons who have migrated to Jammu and Kashmir State from that part of the State which is held by Pakistan; and

(b) the causes therefor?

The Minister in the Ministry Home Affairs (Shri Datar): (a) Jammu and Kashmir Government report that about 8000 persons moved across to our side of the cease-fire line during 1952-56. Earlier figures have not been reported.

(b) The main cause is the insecurity and economic distress in Pakistan occupied Kashmir

CORRECTION OF ANSWER SUPPLEMENTARY QUESTION ON STARRED QUESTION NO. 1257

The Deputy Minister of Defence (Sardar Majithia): In reply to first supplementary arising out of Starred Question No. 1257, which was answered on the 17th December 1956, the Minister of States for Home Affairs replied that so far training at the Himalayan Mountaineering Institute was being imparted to the personnel of the Defence Ministry only and that the question of organising similar training for the personnel of other Ministries or for non-officials was also being considered.

The correct position is that the Institute, which is a private registered body, imparts training not only to Defence Services personnel but also to other civilian Government servants and non-officials. In fact, of the 168 trainees who received training at this Institute so far, only 68 were from the Defence Services. The error in the answer is regretted.
