Shri Karmarkar: For blenders alsoand some of the fine tobacco which my hon. friend knows about.

TEA ESTATES IN ASSAM

- *2112. Shri Sanganna: (a) Will the Minister of Commerce and Industry be pleased to state whether it is a fact that European Tea planters in Assam have been contemplating to divert their capital to the Tea gardens in East Africa with a view to abandoning the Indian Tea gardens ultimately?
- (b) If so, what steps do Government propose to take to protect the interests of the Indian Tea Industry?

The Minister of Commerce (Shrikarmarkar): (a) Government have no information.

(b) Does not arise.

Shri Sanganna: May I know whether Government are in receipt of such reports from any part of India?

Stri Karmarkar: I have not received any reports to the effect that they are trying to shift to East Africa.

Shri N. M. Lingam: Are Government not aware that some of them have already shifted to Kenya and Nyasaland?

Shri Karmarkar: I said we are not aware.

REPORT BY M. L. As. ON HIRAKUD DAM

- *2113. Shri Gidwani: Will the Minister of Irrigation and Power be pleased to state:
- (a) whether the attention of Government has been drawn to a report submitted by 23 Members of the Orissa State Assembly, who visited the Hirskud Dam recently and published in the "Times of India" Delhi Edition dated the 24th April, 1953, on page 5;
- (b) whether it is a fact that the work on the Dam is greatly hampered because 50 costly machines have long been idle for want of minor repairs, as stated in the above report;
- (c) whether large quantities of serviceable tools and material have been scrapped, as alleged by them; and
- (d) whether the members have asked for a thorough investigation into the matter?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) Government have seen the news items published in the "Times of India" but they

are not aware of the contents of the report referred to therein. It is understood that the report was submitted to the Chief Engineer of Orissa.

- (b) 32 machines are off the field at present of which only 12 have been idle for nearly a year. Sickness of these machines is of the order of 30 per cent, which is somewhat more than what it should be under ideal conditions. Work has been affected to this extent. The main difficulty has been in the procurement of spare parts for these specialised machines. Arrangements are being made for expeditious supplies.
 - (c) No, Sir.
- (d) Government are not aware of this recommendation.

Shri Gidwani: Have the Government made any enquiry from the Government of Orissa of the facts of the case?

Shri Hathi: Yes; we have addressed a letter to the Chief Minister of Orissa in this behalf.

Shri Gidwani: What is his reply?

Shri Hathi: We have not yet received it.

Shri T. N. Singh: Is it a fact that there has been greater wear and tear of parts of some of the machines than ordinarily expected?

Shri Hathi: That has not been thecase, with all the machines that havebeen out of order, but in the case of some that has been so.

Shri T. N. Singh: Is it true that Government or the authorities there had to import spare parts for these machines by air even, because the machines were lying idle?

Shri Hathi: Because the work wassuffering some parts had to be sent for even by air.

Shri Sarangadhar Das: Will Government please obtain a copy of that report submitted by the Members of the Orissa Assembly to the Chief Minister and lay it on the Table of the House?

Shri Hathi: We shall address the Chief Minister of Orissa and get a copy of the report.

Shri Sinhasan Singh: May I know when these machines were imported and how long after their import they went out of order and have been lying idle?

Shri Hathi: I have got detailed information as to for what period each

machine is lying idle. There are 32 machines in all. It will take a long time to read out the nistor, and the machine. I am prepared to give the machine to the hon. time to read out the history of each nesessary information to the Member.

Shri Sinhasan Singh: I asked since when and how long after import have they been lying idle?

Mr. Deputy-Speaker: There are 32 machines; all of them are not lying idle simultaneously. Each one would have gone out of order at a particular time. Is he to go on reading the statement?

Shri K. K. Basu: Will the Minister gives us information about the number of machines which never worked at all?

Shri Hathi: They have worked: not that they have not worked.

Shri Altekar: May I know whether the machines were tested and they were in working order when came to India?

Shri Hathi: They were in perfect order and they have been working. Some of them are lying idle, because specialised machine tyres are not available and some other spare parts are not available.

Shri Gidwani: What is the total cost of those machines?

Shri Hathi: These 32 machines, or all the machines?

Shri Gidwani: All the machines.

Shri Hathi: I would require notice for that.

Shri Sarangadhar Das: May I know if sufficient spare parts (say 10 per cent.) were not imported along with the machines?

Shri Hathi: Some spare parts were imported. But, unfortunately, the parts that are wanted are not here.

Shri T. N. Singh: Is it not obligatory on the part of the suppliers to keep ready with them either in stock, or supply Government in advance, necessary spare parts—at least wearable ones?

Shri Hathi: That is what I stated. Some spare parts were available, but these are not the spare parts that are now required.

Shri T, N. Singh: If the supply of spares is not satisfactory and not made in time, what steps do Government take to complain to them or to get the necessary restitutions or losses?

Shri Hathi: Necessary steps will be taken.

STUDENTS PARTICIPATING IN COMMUNITY PROJECT WORK

*2114. Dr. Ram Subhag Singh: Will the Minister of Planning be pleased to state:

- (a) whether the Government have prepared any scheme for participation of students in community project work during the summer vacations;
- (b) if so, what facilities will be given under this scheme to students who participate in the community project work; and
- (c) whether these facilities will also be given to any group of social or political workers who offer to work in the community project centres?

The Deputy Minister of Irrigation and Power (Shri Hathi); (a) There is a provision in the Plan for this purpose but the schemes are actually prepared by the organizations concerned.

- (b) Grants-in-aid are admissible to-wards expenditure on boarding and contingencies. Other facilities local transport and the required tools, implements and materials w be provided wherever possible. will also
- (c) No. Sir. Social and Political workers have opportunities to render useful service through voluntary organizations, like the Bharat Sewak Samaj and other non-political social welfare organizations.

Dr. Ram Subhag Singh: May I know whether the hon. Minister is in a position to say the approximate number of students and teachers who are likely to participate in this work in the coming summer?

Shri Hathi: I cannot say as to how many are likely to come, but I can say that 1.600 students are actually taking part today.

Dr. Ram Subhag Singh: May I know whether the cost of boarding and lodg-ing of these 1,600 students is being borne by the Government of India?

Shri Hathi: All the cost is not being borne by the Government of India, but a ceiling has been fixed which would meet some of this expenditure, and that ceiling is twelve annes per stugent.
