(b) if so, what was the cause of the explosion?

The Deputy Minister of Works, Housing and Supply (Shri Anil K. Chanda): (a) The explosion occurred in a labour camp at village Govind-pur about a mile from Deogarh on the 7th April, 1960, in which twelve persons died and one person was injured.

(b) A Magisterial enquiry into the causes of the explosion as envisaged in section 9 of the Indian Explosives Act, 1884, has been ordered. The enquiry has not yet been completed. The report of the enquiry officer is awaited to determine the cause of the explosion.

## Indo-Pakistan Border

- (a) the progress made so far in the demarcation of the disputed territories of Chak, Ladheke and Rakhhardsingh villages;

The Parliamentary Secretary to the Minister of External Affairs (Shri Sadath Ali Khan): (a) Boundary pillars have been constructed in these areas. Subsequent processes, such as final traverse, mapping, etc., remain to be completed.

- (b) Government have no precise information as to the likely date.
- (c) Accurate figures can be compiled only after completion of demarcation work in the Punjab (India)—West Pakistan sector.
