(iii) A limited number of stipends and book grants will be given to scholars from the primary to the postgraduate levels.

These concessions will be restricted to the children of political sufferers whose income does not exceed Rs. 300 per month. Details are being worked out.

Kerala Chief Minister's Statement

*364. Shri Maniyangadan: Shri Raghunath Singh: Shri Mohammed Imam:

Will the Minister of Home Affairs be pleased to state:

- (a) whether it is a fact that the Chief Minister of Kerala made a statement that there will be civil war if the opposition parties in Kerala join together and form a united front;
- (b) whether Government are aware that the statement has created fear and anxiety among the public and among workers of political parties based on democratic principles; and
- (c) what steps, if any are being taken by Government to allay such fears?

The Minister of Home Affairs (Pandit G. B. Pant): (a) I have not seen the text of the speech. As stated by the Chief Minister of Kerala, the report that was published in the papers was not complete and did not give a correct impression of what he said.

- (b) Such feelings have been expressed by certain persons and organisations.
- (c) The Government of India have not taken any action. There was some correspondence between the Prime Minister and the Chief Minister of Kerala.

The Minister of Education (Dr. K. L. Shrimali): (a) and (b). The Manipur Administration proposed in June 1967 to construct a Sports Stadium in Manipur but this was not approved by the Government of India.

The Minister of Steel, Mines and Fuel (Sardar Swaran Singh): (a) Yes.
