(b) if so, the total amount of stones imported so far;

(c) what is the rate per thousand cubic feet of such imported sandstone;

 (d) whether it is possible to collect sand stones in Tripura itself at a cheaper rate; and

(e) if so, what steps have been taken in the matter?

The Minister of Shipping in the Ministry of Transport and Communications (Shri Raj Bahadur): (a) to (e) A statement giving the requisite information is placed on the Table of the House.

#### STATEMENT

(a) Yes, Sir.

(b) Against orders placed for two lakh cubic feet stone boulders, 30,000 cubic feet have so far been collected by the Tripura Public Works Department at Agartala and 5,000 cubic feet at Belonia.

(c) The cost of imported stone houlders at Agartala is Rs. 2,375]- per thousand cubic feet and at Belonia Rs. 2,760/- per thousand cubic feet. However, at places like Dharmanagar and Kallashahar, which are nearer to the Assam region, there is no difference between the costs of Assam Stone and Tripura Stone. The cost of Assam stone at Dharmanagar is Rs. 1,040]per thousand cubic feet which is the same as that of the Tripura stone.

(d) No. It is not possible to meet full requirements of stone boulders from areas within Tripura because stone is extremely scarce in the entire State.

(e) Does not arise.

(b) Bank guarantee or security deposit account from a corporate body; security bonds from individuals.
