PRODUCTION OF NATURAL RUBBER

*173. SHRIMATI GEETA MUKHER-JEE : Will the Minister of COMMERCE be pleased to state :

(a) whether the Government have drawn up a perspective plan to achieve self sufficiency in the production of natural rubber by 2000 A.D.;

(b) if so, the details thereof; and

(c) the stage at which this plan stands at present ?

THE MINISTER OF STATE IN THE MINISTRY OF CIVIL SUPPLIES, CON-SUMER AFFAIRS AND PUBLIC DIS-TRIBUTION AND MINISTER OF STATE IN THE MINISTRY OF COM-MERCE (SHRI KAMALUDDIN AHM-ED): (a) to (c) Yes Sir. A perspective plan has been drawn up to achieve selfsufficiency in the production of natural rubber subject to availability of funds. This plan includes the following strategies to augment the production of natural rubber in the country :--

- (i) Expand the area under rubber cultivation by bringing more and more non-traditional regions under plantation.
- (ii) Spread-up replantation of old and low yielding areas with modern high yielding cultivars.
- (iii) Raise reductivity of existing mature plantations by popularising adoption of modern technology.

This comprehensive perspective plan involves an outlay of Rs. 270 crores between the period 1992-93 to 1996-97. The Plan outlay for the current year 1993-94 is Rs. 42.38 crores which includes a foreign aid component of Rs. 16.41 crores.

In order to achieve the target as set out by the perspective plan and to augment the availability of funds, the Rubber Board has recently finalised a comprehensive project with the World Bank with a total foreign aid of US \$ 92.0 Million. This project is likely to commence after necessary portocols are signed during the current year. After the implementation of the World Bank Project by 1997-98, possibilities can be explored by the Rubber Board to finance the rest of the schemes as envisaged in the perspective plan to achieve self-sufficiency.

HANDLOOM WEAVERS

*175. SHRI NITISH KUMAR : PROF. UMMAREDDY VENKA-TESWARLU :

Will the Minister of TEXTILES be pleased to state :

(a) the total number of handloom weavers in the country, State-wise;

(b) whether the Government have prepared any concrete schemes for their upliftment and welfare; Tax (IATT) at the rate of 15% of the ticket value in accordance with Finance Act, 1989 read with IATT Rules, 1989.

(b) Yes, Sir.

(c) Details of air taxi operators against whom arrears of IATP are outstanding and the estimated amounts reported by the Ministry of Finance are as follows :

- -Rs. 11.31 lakhs up to March, 1993 -Rs. 63.15 lakhs up to February, 1993.
- -Rs.35.83 lakhs up to November, 1992
- -Rs. 14.28 crores up to February, 1993

(c) if so, details thereof; and

(d) the time bound programme for implementation of these schemes ?

THE MINISTER OF STATE OF THE MINISTRY OF TEXTILES (SHRI G. VENKAT SWAMY) : (a) The State-wise data on number of handloom weavers is given in the *statement* attached.

(b) and (c) The Government of India is implementing various schemes for upliftment and welfare of handloom weavers including workshed-cum-housing scheme, Thrift Fund Scheme, Group Insurance Scheme and Health Package Scheme.

(d) These schemes are ongoing schemes, and are implemented on a continuous basis.
