DESU TRANSFORMERS

*279. SHRI G. DEVARAYA NAIK: SHRI MADAN LAL KHURANA:

Will the Minister of POWER be pleased to state:

- (a) whether there is acute shortage of transformers with the Delhi Electric Supply Undertaking:
- (b) if so, the details thereof and the reasons therefor:
- (c) whether DESU propose to introduce the system of mobile power transformers:
- (d) if so, the details thereof indicating the estimated cost involved: and
- (e) if not, the other steps taken or proposed to be taken to remove the shortage of transformers?

THE MINISTER OF POWER (SHRI N.K.P. SALVE): (a) to (e) Recently there has been some shortage of Distribution Transformers with DESU due to contractual problems with the suppliers. DESU has already taken necessary action to ensure regular supply of transformers by the manufacturers, speedy replecement/repairs of transformers which failed within the warranty period. Additional quantities of Transformers commensurate with the requirements are also being acquired. Special drive has also been undertaken to repair damaged transformers at the departmental workshop to supplement the stock. The position regarding availability of transformers is now satisfactory. Provisions of Mobile Transformors already exists at all the six Distribution Circles of DESU to meet the emergency situations.
