

The recommendations yet to be finalised are those contained in Chapter VI (emergency Provisions) and Chapter X (Financial Relations) of the report of the Commission.

The Government intends to pursue a two track policy. On the first track, the recommendations of the Sarkaria Commission on which there is already a broad consensus are proposed to be implemented through legislation and administrative action as appropriate. On the second track, the Government proposes to appoint a High Level Committee to review and update the recommendations of the Sarkaria Commission and look into the vital question of devolution of financial powers from the Central Government to the State Governments.

#### Production of Rubberwood

(c) if so, the steps being taken by the Government to increase the production of rubberwood in the country?

THE MINISTER OF STATE OF THE MINISTRY OF ENVIRONMENT AND FORESTS (CAPT. JAI NARAYAN PRASAD NISHAD) : (a) No, Sir. According to the State of Forest Report, 1993, the total forest cover of the country as per 1993 assessment has increased by 925 sq. km. in comparison to 1991 assessment.
