(b) Identification and development of new tourist places is an on-going process and is primarily the responsibility of the State Governments.

(c) During the IXth Five Year Plan ITDC proposes to construct a 100 room Five Star Hotel at Chandigarh at an estimated cost of Rs. 33.95 crores.
