- (b) Does not arise.
- (c) There is a Returned Letter Office for every Postal Circle exclusively or commonly with one or more neighbouring Circles. The Government has no plan either to close any Returned Letter Office or to open any new office.

Share of Rajasthan from Tehri Dam Waters

2279. SHRI GIRIDHARI LAL BHARGAVA: Will the Minister of WATER RESOURCES be pleased to state:

- (a) whether the Government of Rajasthan has requested the Union Government to expedite the matter relating to share of Rajasthan from Tehri Dam waters; and
- (b) if so, the reaction of the Union Government thereto and the steps being taken in this regard?

THE MINISTER OF WATER RESOURCES (SHRI VIDYACHA-RAN SHUKLA): (a) and (b) The Government of Rajasthan made a reference to the Union Government to persuade the Government of Pradesh to allocate 10% of Dam Project Waters for areas in Rajasthan. The matter was accordingly taken up with the Government of Uttar Pradesh who informed the Government of Rajasthan in July. 1988 as also to this Ministry in September, 1988, that in view of commitments of Ganga Waters at Tehri Dam Project, it did not appear possible to supply waters to areas in Raj-The Raiasthan Government asthan. was advised in October, 1988 to bring up the matter before the Inter-State Meeting on Yamuna. The meeting of the Standing Committee on Inter-State issues in Water Resources to discuss the Yamuna dispute was held in September, 1990 but this issue did not come up for discussion.

- (a) the progress made in the fencing of the International border between India and Bangladesh;
- (b) whether there is any dispute with Bangladesh on the fencing issue; and
 - (c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF PARLIAMENTARY AFFAIRS AND MINISTER OF STATE IN THE MINISTRY OF

HOME AFFAIRS (SHRI M. M. JA-COB): (a) So far, fencing for a length of 36.57 Kms. has been done on the Indo-Bangladesh border.

Bharat Refractories Ltd. not to implement the proposed Pithoragarh Magnesite Project as it was felt that consequent to shift in the demand pattern of refractories, the project would be unviable.

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI K. C. LENKA): The State Government of Maharashtra has reported that during the year 1990-91 per capita consumption of milk in urban areas was 107 grams while in the rural areas it was 126 grams.
