Karnataka and Maharashtra; river Godavari among the States of Maharashtra, Karnataka, Andhra Pradesh, Madhya Pradesh and Orissa: river Narmada among the States of Gujarat, Madhya Pradesh. Maharashtra and Rajasthan; have already been resolved by the Centre through constitution of Tribunals. The further reports of these Tribunals were given on 27-5-1976, 7-7-1980 and 7-12-1979 in respect of Krishna, Godavari and Narmada waters disputes respectively.

Impact of Bovine Growth Hormone on Animals and Human Beings

- (b) The hormone was found to be effective for water buffaloes when administered daily in doses of 25 mg and 50 mg, intramuscularly. The observed increase in milk production was 16.8 to 29.5 per cent.
- (c) to (e) Research trials in NDRI and NDDB have been conducted to assess the effect of BGH on the health of lactating crossbred cows and buffaloes. So far no adverse effect on animal or human health has demonstrated by the use of BGH.
