Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:

- (a) whether the Government has started Pradhan Mantri Shram Yogi Maan-dhan Yojana (PM-SYM) and if so, the details thereof;**
- (b) whether the labourers belonging to Maharashtra, Chhattisgarh, North East, Karnataka, Rajasthan and Jharkhand particularly belonging to Madha, Latur, Bilaspur, Durg, Kanker, Jalore, Sirohi, Chatra Constituencies and have also been benefitted by the said scheme and if so, the details thereof till date;**
- (c) the time since when PM-SYM was introduced to provide pension for workers in unorganised sectors and the procedure for selection of beneficiaries under the said Yojana;**
- (d) whether any criteria have been fixed for the beneficiaries and if so, the details thereof; and**
- (e) the number of approved pending applicants and the details of the amount payable to the beneficiaries during the last three years, year-wise and district-wise along with the number of beneficiaries under the said scheme in Maharashtra, Chhattisgarh, Assam and North East States, Rajasthan, Karnataka, Jharkhand and district-wise in Jalore and Sirohi in Rajasthan?**

ANSWER

(a) to (e): The Government of India launched Pradhan Mantri Shram Yogi Maan-Dhan Yojana (PM-SYM) in February, 2019 to provide a monthly pension of Rs. 3000/- after attaining the age of 60 years. The eligibility criteria for registration under the scheme is as under;

- I. should be an unorganized worker;**
- II. Entry age between 18-40 years;**
- III. monthly income Rs. 15000 or below**

Apart from the above, a person should not be engaged in an organised Sector (Membership of EPF/NPS/ESIC) and not an income tax payer. The constituency wise data on registration is not maintained. The details of registered workers belonging to Maharashtra, Chhattisgarh, North East, Karnataka, Rajasthan and Jharkhand is as per Annexure.

No beneficiary enrolled under the PM-SYM has completed 60 years of age to become eligible to receive the pension.
