### PRICE OF RAW MATERIALS FOR MSMEs

## 165. SHRI THIRUMAAVALAVAN THOL:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) whether the Government is aware of the price of raw materials such as metals, plastics, etc., for Micro, Small and Medium Enterprises (MSMEs);
- (b) if so, whether the raw material prices have affected MSMEs productions;
- (c) if so, whether there is decline in the demand for MSME products in the recent years;
- (d) if so, the details thereof; and
- (e) the measures taken by the Government to support MSMEs?

### **ANSWER**

# MINISTER OF STATE FOR MICRO, SMALL AND MEDMUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

(a) to (d): The price of raw materials such as metals, chemicals, plastics, rubbers etc., is monitored through the Wholesale Price Index (Base 2011-12). The details are at **Annex-1**.

The Ministry of Micro, Small and Medium Enterprise (MSME) does not maintain data with respect to effect of raw material prices on production or aggregate demand of MSME products.

(e): The Government has taken several steps to support MSMEs which inter alia include, providing financial assistance under Raw Material Assistance (RMA) Scheme of National Small Industries Corporation Limited (NSIC), Exemption on Basic Custom Duty on steel scrap has been extended for up to 31st March, 2023, TMT bars below 8 mm have been exempted from the purview of the Quality Control Order & waived off import duty for several raw materials like coking coal, Ferro-nickel etc.
