105. SHRI KESINENI SRINIVAS:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of the projects completed under the Scheme of Fund for Regeneration of Traditional Industries (SFURTI) scheme since its inception, State-wise;
- (b) whether the Government has carried out any study to estimate the credit gap being faced by the MSME sector due to COVID-19 and if so, the details thereof;
- (c) the funds disbursed by both public sector and private sector banks to MSMEs during the last five years, State-wise; and
- (d) the percentage of loans taken by MSMEs that have turned NPAs during the last five years, State-wise?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a): As on date, 498 clusters have been approved under Scheme of Fund for Regeneration of Traditional Industries (SFURTI), benefitting around 2.94 lakh artisans, with Government of India assistance of Rs. 1292 cr. Of the approved clusters, 272 clusters have become functional till date. The State-wise list of Functional and Under Implementation clusters is placed at **Annexure-I**.
- (b): Any specific study to estimate the credit gap being faced by the MSME sector due to COVID-19 has not been done by the Ministry of MSME.
- (c): State-wise list of credit disbursed to MSME Sector by Scheduled Commercial Banks is placed at **Annexure-II**.
- (d): The gross NPAs of MSME sector with Scheduled Commercial Banks during last five years is placed at **Annexure-III**.
