- (a) whether all the districts of Uttar Pradesh, Bihar and Haryana are included for financial assistance from Central Road and Infrastructure Fund (CRIF);**
- (b) if so, the details thereof, district-wise including districts of Sitamadhi and Sonipat; and**
- (c) the targets set for development and maintenance of roads in the country including the said States during the next three years?**

ANSWER

THE MINISTER OF ROAD TRANSPORT & HIGHWAYS

(SHRI NITIN JAIRAM GADKARI)

(a) & (b) Financial assistance under CRIF is released State wise and not district wise. The details of accrual/ allocation of funds and the funds released/ expenditure incurred for development and maintenance of State roads under CRIF in States of Uttar Pradesh, Bihar and Haryana during each of the last three years and current year, are at Annexure. Ministry is primarily responsible for development and maintenance of National Highways in the country. Ministry allocates funds for State Governments / Union Territories (UTs) for development and maintenance of National Highways State wise and not district wise.

(c) Ministry envisages to construct 13,000 km of NHs during the next financial year 2023-24 as part of Ministry's vision to construct 60,000 km of NHs during the period from 2019-20 to 2023-24. However, State-wise target for the same have so far not been fixed. The targets for the years 2024-25 and 2025-26 have not yet been fixed.
