CSR SPENDING IN UTTAR PRADESH

QUESTION

4332. SHRI GHANSHYAM SINGH LODHI:

Will the Minister of CORPORATE AFFAIRS be pleased to state:

- (a) the details of the work undertaken by utilizing the Corporate Social Responsibility (CSR) fund in the country, company-wise;**
- (b) the details of the CSR fund spent in Rampur district of Uttar Pradesh during the last five years, company-wise and sector-wise;**
- (c) the details of the reasons for not spending the CSR fund in Rampur by any company; and**
- (d) whether the CSR fund has been spent even on the unrecognized institutions and if so, the details thereof?**

(a): The broad framework for Corporate Social Responsibility (CSR) has been provided under Section 135 of the Companies Act, 2013 ('Act'), Schedule VII of the Act and Companies (CSR Policy) Rules, 2014. On the basis of annual filings made by Companies in the MCA21 registry, details of CSR funds spent by all companies, in different States/Union Territories (UTs) for the Financial Year (FY) 2016-17 to 2020-21 is given below:

(b) & (c): All data related to CSR filed by companies in MCA21 registry, including Development Sector-wise and Company-wise, is available in public domain at www.csr.gov.in. The details of CSR spent by companies in Rampur district of Uttar Pradesh State during last five Financial Years (FY) 2016-17 to 2020-21 is given below:

Further, the companies are required to file the CSR data for the financial year 2021-22 on or before 31.03.2023.

Under the Act, CSR is a Board driven process and the Board of the company is empowered to plan, decide, execute and monitor CSR activities based on the recommendations of its CSR Committee. The Government does not issue any specific direction to the companies to spend in any particular geographical area or activity.

(d): Schedule VII of the Act indicates the eligible list of activities that can be undertaken by the companies as CSR activities. The CSR framework is disclosure based and companies are required to file details of CSR activities annually in the MCA21 registry. Whenever any violation of CSR provisions is reported, action against such non-compliant companies is initiated as per provisions of the Companies Act, 2013 after due examination of records and following due process of law. Now, the non-compliance of CSR provisions has been converted as a civil wrong w. e. f. 22nd January, 2021.
