- (a) the details of steps taken by the Government to give professional education through skill development initiative in Bhadohi, Uttar Pradesh during the last three years;
- (b) the number of students who got placement/ job in any Government or private establishment after training;
- (c) whether the students after training applied for Mudra loan for self-employment; and
- (d) if so, the details of total Mudra loan sanctioned to help these young trainees to start their own work?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF LOK SABHA STARRED QUESTION NO. *446 TO BE ANSWERED ON 03.04.2023 ASKED BY SHRI RAMESH CHAND BIND REGARDING PROFESSIONAL EDUCATION THROUGH SKILL DEVELOPMENT

(a) Under the Skill India Mission, Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, Re-Skill and Up-Skill training to youth across the country including district of Bhadohi, Uttar Pradesh through a comprehensive network of skill development centres/institutes under various schemes viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs). The number of persons trained under above mentioned schemes in Bhadohi District of Uttar Pradesh during last three years (2019-20 to 2021-22) is as under:-

(b) Placement opportunities were facilitated to Short Term Training (STT) certified candidates under PMKVY, while Recognition of Prior Learning (RPL) was not linked with placements as it recognized the existing skills of candidate. The number of persons trained, certified, reported placed under PMKVY in the Bhadohi, Uttar Pradesh, since beginning of the scheme and till 31st December, 2022 is as under:-

As regards other Schemes, as per the third party evaluation reports, there is success in terms of placement or enhancement of income of candidates trained. As far as the employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident. The report has further observed that usefulness of the scheme would be further evident from the fact that 77.05% of the beneficiary trainees have undergone occupational shifts. The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, Gol) mentions that 63.5% of total ITI pass-outs got employed (wage+ self, out of which 6.7% are self-employed).

(c) and (d) The Pradhan Mantri Mudra Yojana (PMMY) was launched on 08.04.2015 to extend collateral free loans up to Rs.10 lakh to individuals to enable them to set up or expand their business activities. The Scheme is being implemented across the country. As per data uploaded on Mudra portal, as on 24.02.2023, over 39.65 crore loan accounts involving a sanctioned amount of Rs. 22.41 lakh crore have been extended since inception of the Scheme. This includes loans extended to students for self-employment as per Scheme guidelines.
