- (b) The price of the HD-19 tractors operated in the State is Rs. 69,490 each, and that of the FDE tractors is 54,580 each. The D7 and D8 tractors are second-hand machines which were taken over from American Army Surpluses on the basis of a lump sum payment for all tractors and certain other items of equipment, and the approximate cost per tractor is about Rs. 10,500. Varying amounts had however, to be spent subsequently on the repair and rehabilitation of these tractors.
- (c) The Madhya Pradesh Government do not pay any amount to meet the cost of the tractors as such. In the charges recovered from the State Government on a no profit no loss basis for reclamation work done by the Central Tractor Organisation, the cost of the tractors is represented under depreciation charges. Depreciation charges for the tractors are calculated for the actual number of hours worked on the basis of a life of 10,000 hours for a tractor.
- (d) A total area of 2,48,784 acreshas been reclaimed by the Central Tractor Organisation in its five years of operations in the State. Out of this, 1,76,009 acres were reclaimed upto the end of the 1950-51 season, and although exact information in the matter has not been received from the State Government, the entire area should have been brought under actual cultivation. The remaining lands which have been reclaimed in the season just ended will be cultivated by the next Rabi season.
- (e) Information in this regard has been called for from the State Government and will be placed on the table of the House as soon as received.,
- (f) This information is also awaited from the State Government. The rate at which recoveries are at present made by the Central Tractor Organisation from the State Government is about Rs. 52 per acre, but the rate at which the latter make recoveries from Kisans is not known.
- (g) In the 1951-52 reclamation season which has just ended, 71 tractors were used in the State.
