The Minister of State for Finance (Shri Tyagi): Since classified statistics of income-tax revenue according to inor income-tax revenue according to in-come groups are maintained for the demand raised, but not for the collections, the figures of actual col-lection made from the group of assesses having income of Rs. 5,000 or less are not available. The amount of tax assessed on incomes up to Rs. of tax assessed on incomes up to Rs. 5.000 was, however, Rs. 2 crores and 30 lakhs during 1950-51. Complete figures are yet not available for the year 1951-52.
