(b) In 96 cases compensation has been paid by the State Government. The remaining 613 cases are still pending, but the State Government is being reminded from time to time to expedite the disposal of these cases.

The Minister of Home Affairs and States (Dr. Katju): (a) and (b). In addition to this provision, the Central Government is directly financing the development programme of the North East Frontier Agency, which is estimated to cost Rs. 3 crores in the plan period.
