- (e) Survey of the project areas has been completed and Budget estimates have been approved. Inoculation of cattle, construction of drains, roads, culverts, dug-hole latrines have also been undertaken. Improved varieties of wheat, field peas, chemical manures, etc. have been distributed. A beginning has also been made with reclamation work.
