COTTON IMPORT

265. Dr. Ram Subhag Singh: Will the Minister of Commerce and Industry be pleased to state:

- (a) the total quantity of cotton to be imported into this country during the first half of the year 1953; and
- (b) how much of this import will be made from dollar area?

The Minister of Commerce and Industry (Shri T. T. Krishnamachari): (a) and (b). A quota of 500,000 bales of 400 lbs. each has been announced for shipment up to end of June, 1953. No licences are being issued at present for imports out of this quota from dollar areas. There is however about 200,000 bales of U.S.A. cotton outstanding for import from the 1951-52 quota.

IUTE IMPORTED FROM PAKISTAN

- **266. Shri B. K. Das:** Will the Minister of **Commerce and Industry** be pleased to state:
- (a) the quantities of jute of different varieties imported from Pakistan during the year 1952;
- (b) the minimum and maximum prices of the jute imported; and
- (c) the total quantity of Indian jute purchased by jute mills during 1952 and the minimum and maximum prices thereof?
- . The Minister of Commerce and Industry (Shri T. T. Krishnamachari):
 (a) The total quantity of raw jute imported from Pakistan during 1952 (January to December) was 14.74 lakhs bales of 400 lbs, each. Details of break-down into various grades are not recorded in official statistics.
- (b) Information is not available as regards the import price. The maximum quotation for Pakistan jute (Jat Bottoms) in the Calcutta market during 1952 is reported to have been Rs. 66 per maund on the 7th January 1952 and the minimum Rs. 27/8/- on the 20th November, 1952.
- (c) The quantity of Indian raw jute purchased by mills during 1952 was about 45 lakh bales. The maximum quotation for Assam Bottoms during 1952 is reported to have been Rs. 62 per maund on the 14th January 1952 and the minimum Rs. 22 on the 28th July 1952. Details about other varieties are not available.

COCOANUT OIL
