WRITTEN ANSWERS TO QUESTIONS

Posts and Telegraphs Staff Quarters

- *48. Shri T. B. Vittal Rao: Will the Minister of Communications be pleased to state:
- (a) whether land has since been acquired for the construction of quarters for Posts and Telegraphs employees in Hyderabad city; and
- (b) if so, when the construction work will be taken up?

The Minister of Communications (Shri Raj Bahadur): (a) and (b). Acquisition proceedings are in progress; construction will be taken up as soon as land is taken possession of and the building estimate also sanctioned.

Posts and Telegraphs Training Centre, Hyderabad

- *55. Shri T. B. Vittal Rao: Will the Minister of Communications be pleased to state:
- (a) when the construction of a Departmental building for housing the Posts and Telegraphs Training Centre at Hyderabad City will be taken up; and
- (b) when it is likely to be completed?

The Minister of Communications (Shri Raj Bhaadur): (a) Construction will not be taken us for the present as due to financial considerations and especially the large capital cost involved, the question of opening large residential P. & T. Centres in various regions has had to be deferred. At present training is being carried out in special non-residential centres opened in the various Circles.

(b) Does not arise.

Border Incidents

- 14. Shri Krishnacharya Joshi: Will the Frime Minister be pleased to state:
- (a) the number of border clashes and exchange of firing between Indian and Pakistani border patrols during 1956 and 1957 so far; and

(b) the nature of such incidents and the loss or damage caused thereby?

The Deputy Minister of External Affairs (Shri Anil K. Chanda): (a) Du.ing the period 1st January 1956 to 15th February 1957, there were at least 21 incidents in which exchange of firing took place. (This figure does not include any incident which might have occurred during the period from the 1st January to 15th February 1957 on the borders along Assam, Jammu & Kashmir and Bombay States, information about which is still awaited).

(b) The incidents occurred because of Pakistani attempts to steal cattle or take forcible possession of undemarcated territory which they held to be in dispute or because of trespass which, later, appeared to have been inadvertent.

Pilgrims from Pakistan

- 15. Shri Krishnacharya Joshi: Will the Prime Minister be pleased to state:
- (a) the number of pilgrims from Pakistan who attended the Urs at Ajmer this year; and
- (b) the facilities provided for the pilgrims by the Government of India?

The Deputy Minister of External Affairs (Shri Anii K. Chanda): (a) and (b). Information is awaited from the Rajasthan Government. It will be placed on the table of the House when received.

Employment Exchanges
